### Official Rules

- How to Enter:** Beginning at 8:00:01 a.m. Pacific Standard Time (“PST”) on November 1, 2010 and ending at 11:59:59 p.m. PST on October 31, 2011 (“Promotion Period”), visit [www.reelz.com/fbwin](http://www.reelz.com/fbwin) (“Web Site”) and follow the onscreen instructions to enter by posting a comment on the MovieTrailersbyREELZ Facebook page. Once you have completed the post, you will be automatically entered into the Random Drawing. Limit one entry per person/Facebook account per prize. Entries must be received by the deadlines posted on [www.reelz.com/fbwin](http://www.reelz.com/fbwin) as related to the prize being awarded to be entered into the Random Drawing.
